



Florida's Minimum Wage Schedule


FLORIDA'S MINIMUM WAGE

After a 60% voter approved constitutional amendment, the state's minimum wage will increase from \$8.65 an hour to \$10 on Sept. 30 (\$6.98 for tipped workers). Under the constitutional amendment, the rate will increase incrementally each year until reaching \$15 an hour (\$11.98 for tipped workers) on Sept. 30, 2026.




Employment by Major Industry


Volusia County Unemployment Trend



Volusia County Commercial New Construction Building Permits








2020-2021 High School, Post-Secondary* and Associate Degree Completions
