The Florida 2030 project offers a strategic blueprint that defines goals and strategies to guide private, public and civic partners as they work together to shape Florida's economic future. The report is based on three years of research and input from more than 10,000 Floridians; it lays out a path for the transformation of Florida into a top 10 global economy that attracts and retains talent at all ages and provides a path to prosperity for every community in the state. **SMALL SAT LAUNCHES** – As reported, just over a thousand small satellites were launched into Earth's orbit between 2012 and 2017. In 2017 alone, the number of small-sat launches reached a record 335. Most small-sat companies expect to wait anywhere from six months to two years before a rideshare to orbit becomes available, so demand is high for more timely launches. Based upon payload costs that are tens of thousands rather than tens of millions, small-sat companies may be willing to try a new type of launch vehicle if this means they can start generating revenue immediately, rather than holding off for two years. Dozens of companies are reportedly in development to cater to the small satellite customer, offering rockets that are small, quick and cheap enough to deploy such that a small satellite company can book a dedicated launch.
