The study is being funded by a Community Planning Technical Assistance grant from the Florida Department of Economic Opportunity.

**GDP COMPARISONS** – As reported by Howmuch.net, the largest state in the U.S. by GDP is California, which has a \$2.97 trillion economy. This makes California not only comparable to Britain, whose GDP came in at \$2.81 trillion, but would also make California the fifth largest economy in the world if it were its own foreign nation. The GDP of Texas is the second largest in the U.S. at \$1.78 trillion, while Canada's follows close behind at \$1.73 trillion. Florida's GDP is the fourth largest at \$1.04 trillion, which exceeds that of Mexico at \$1.02 trillion. Howmuch.net provides visualizations about money and offers in-depth cost guides and tools.

**ATLANTA FED NOTES TIGHTENING LABOR CONDITIONS IN SOUTHEAST** – Some small businesses are reporting particular challenges competing with larger companies for a dwindling pool of available workers. This according to the Atlanta Federal Reserve Bank's latest southeast region Beige Book release, or regional economic conditions summary, for January. Businesses continued to report pressure to increase wages for low-skill, hourly jobs, notably in the hospitality and retail industries. The release also noted that national statistics showed growing numbers of Americans are switching jobs. In that context, the Beige Book's information, gathered from construction, manufacturing, and health services industry contacts, indicate overstaffing is occurring for certain jobs to prepare for anticipated growth, figuring it will be difficult to find people in the coming months.
