**VOLUSIA COUNTY COVID-19 PUBLIC INFORMATION NETWORK** – Stay up to date with COVID-19 related news and emergency information via Volusia County's [public information network](#). The webpage includes links to local municipalities, agencies, the CDC, Florida Department of Health, schools and colleges. It also features Volusia County news releases and FAQs, along with information about assistance programs and resources, beach safety, coastal and county parks, cancellations and closures, and virtual education and entertainment resources.

**IRS COVID-19 TAX RELIEF** – The IRS has established a special section of its website to help taxpayers, businesses and others affected by the coronavirus. The webpage will be updated as new information becomes available. Among others, updates include the U.S. Treasury and IRS having [extended filing deadlines to July 15 and federal tax payments](#) regardless of amount. In addition, the U.S. Treasury, IRS and U.S. Department of Labor announced that [small and midsize employers can begin taking advantage of two new refundable payroll tax credits](#) designed to immediately and fully reimburse employers, dollar-for-dollar, for the cost of providing coronavirus-related leave to their employees.

**CDC OFFERS COVID-19 RELATED GUIDANCE ON MAINTAINING HEALTHY BUSINESS OPERATIONS** – In addition to health care guidance, the CDC provides implementable [guidance concerning non-health care settings such as business and workplace environments](#). This includes guidance on maintaining healthy business operations, addressing such areas as identifying a COVID-19 workplace coordinator, implementing flexible sick leave and other supportive policies and practices, identifying essential business functions and practices, response plans for absenteeism spikes, and establishing social distancing practices.

**DAYTONA STATE COLLEGE OFFERS FREE WEBINAR ON ENHANCING WORKFORCE RESILIENCE DURING COVID-19** – Join the conversation to explore how you can strengthen your workforce's resilience, ensuring success in managing change and uncertainty. Updating community population levels has become more significant than ever. By now, all Volusia County residents should have received their invitation to respond to the 2020 Census. There is no better time to [complete this important questionnaire](#) with many residents self-quarantining due to COVID-19. The census is so important that responses are required by law. Results from the 2020 Census will be used to direct billions of dollars in federal funds to local communities for schools, roads and other public services; help your community prepare to meet transportation and emergency readiness needs; and determine your political representation at all levels of government. Responses are due by April 1.
