ENTERPRISE FLORIDA EXPORT SALES MISSION TO COLOMBIA COMING IN NOVEMBER – Enterprise Florida (EFI) is recommending Florida companies consider expanding their export sales by joining the trade mission to Bogota, Colombia, Nov. 18-22. Colombia is the fourth-largest economy in Latin America and has the third-largest population in the region with approximately 49 million citizens. With nearly \$4.2 billion of merchandise shipped in 2017 – and growing by nearly 7% in 2018 – Colombia ranked as Florida's second-largest export market. EFI will offer a limited number of Gold Key Service Packages (one-on-one appointments) through the U.S. Commercial Service to qualified Florida companies. Companies who qualify for the Gold Key as a small business based on SBA size standards may qualify for a Gold Key Grant from Enterprise Florida. CULINARY ARTS ACADEMY – The academy at New Smyrna Beach High School utilizes the industry-standard ProStart curriculum to teach students industry skills in the hospitality and tourism career cluster. Students in the advanced courses are responsible for the operation of Cuda Café, a school-based restaurant that serves 100 to 150 people twice weekly; and for Cuda Catering, a catering service available to community organizations. RISE IN SELF-EMPLOYED CHALLENGES THE COMMON WISDOM – According to the U.S. Census Bureau, the rise in the number of self-employed has altered what people understand a business to be. The common wisdom considers a business as a brick-and-mortar place of work with employees and managers who have benefits and paid time off. However, the latest available data indicates that more than three-fourths of U.S. businesses may be run out of someone's home and have zero employees. Last October, the Census Bureau released a new report that combines the data published on employer businesses with data on businesses without paid employees, or "Nonemployers." According to the Nonemployer Statistics program, there were almost 25 million nonemployer businesses in 2016, accounting for more than 76.2% of all businesses. These are businesses with no paid employees and are subject to federal income tax. They are present in nearly every sector of the U.S. economy. AI ADOPTION TRENDS AND CHALLENGES – Earlier this year, O'Reilly Media reported on emerging trends, hurdles and best business practices in artificial intelligence adoption arising from surveys released in 2018 and early 2019. Looking across industry sectors, technology, health care and retail tended to be the leaders in AI adoption, whereas education, manufacturing and the public sector (government) was found to lag behind. The finance sector was found to enjoy first-mover advantages in artificial intelligence adoption, as have the technology and retail sectors. O'Reilly found that 70% of respondents from the health sector used AI for research and development projects. Health care sector survey respondents also had significantly less difficulty identifying appropriate use cases for AI. An overall note of caution was sounded as issues such as overcoming challenges related to company culture or not being able to recognize the business use cases were evident in survey outcomes.
