AMERICAN INSTITUTES FOR RESEARCH REPORT RELEASED – What is the personal economic impact of post-secondary education in Florida? American Institutes for Research has released the 2018 Economic Security Report titled "Measuring the Economic Success of Florida's Graduates." The research shows that economic outcomes are correlated with a student's selected degree or certificate, credential level and institution. The report details economic outcomes of recent completers from Florida's public postsecondary educational institutions and aims to document the variation in earnings, employment, continuing education and public assistance among completers who have earned degrees or certificates from these schools. CLEAN ENERGY CREATING JOBS – According to a new report by E2, more than 110,000 net new clean energy jobs were created nationwide in 2018, bringing the total number of Americans who work in clean energy to 3.26 million. While jobs in solar declined in part because of tariffs on steel and solar panels, wind energy jobs grew by nearly 4 percent and now competes with fossil fuels in many markets. Driven by growing consumer demand, the number of jobs in clean vehicles manufacturing increased by 16%. Visit www.e2.org/reports/clean-jobs-america-2019/ to access the E2 report.

EMPLOYMENT GROWTH IN CANNABIS INDUSTRY – According to a report by Leafly, the number of full-time jobs in the legal U.S. cannabis industry is now at 211,000. The report said there are now more legal cannabis industry workers in the U.S. than dental hygienists. By comparison, coal mining jobs currently number 52,000, brewery jobs stand at 69,000, and textile manufacturing jobs total 112,000. Florida topped the states in terms of the absolute number of jobs added, as the state added 9,068 cannabis jobs in 2018, a 703% increase to 10,358, Leafly said. The Sunshine State is followed by Nevada, which has seen a 181% increase to 7,573 jobs. Visit http://tinyurl.com/y4djywgs to view the report.
