

Volusia County & Florida Population Trend






Volusia County – Migration Inflow/Outflow

Volusia County Population by Age Cohort




Volusia County Population by Age Cohort – Percent Change






Volusia County Employment Migration Inflow/Outflow







Valueia County Nat Worker Out-Migration by Inductry






Transportation Infrastructure Expansion Investment by Type - Volusia County

Lane Widening & New Road Lanes \$226.8M






Major Volusia County Road Use – 5 Year Traffic










Volusia County Commercial New Construction Building Permits






